Responsibility, a matter of transparency?


- To communicate and share problems
- To admit the mistake (example of the pilot behaviour), even if it has been fixed
- Mobbing → misuse of transparency
- Is it always positive to share information?
- What does transparency mean?
- Selected information vs. every information
- To take the risk
- Responsibility imposed by the law vs. creative way of building it
- People have to know for what they are responsible (example of children vaccination)
- The law is materialised responsibility
- To be able to know by myself which are my responsibilities → ethics
- Where do I find reliable information?
- Timing: to communicate to early or to late → risk of the media creating the story
- Intuition
- Sometimes to know less I better
